5. Visit Scotland Growth Fund Bid	HIE were unable to match the private funding due to restrictions on marketing support. However the Community Council has supported an application to the Common Good Fund for £15k (JC to send a letter of thanks). HIE provided special assistance to help develop the grant bid, which is at the final review stage. A decision is due on 27 th February, but the campaign will need to be ready to go on 1 st March! 5 bids had been received for the marketing campaign, 2 of which had not supplied the detailed financial breakdown requested. A further 2 had additional costs of £10k-£11k to develop the initial conceptual design. The bid from Purple Frog therefore represented best value for money.	JC
