Green Certification Schemes for Tourism Businesses

The Sustainability Certification Fund for Tourism Recovery has been allocated to Green Tourism, Green Key and EarthCheck who will now be able to offer a £500 discount on their membership fees to those within the tourism industry looking to gain green certification. Please note – spaces for businesses are limited on each scheme.

New Community Cycling Fund

Developed with the aim of creating a national celebration of cycling across Scotland in the build up to the 2023 UCI Cycling World Championships. It is made up of two-separate funding opportunities —

- The Development strand open to all 32 Scottish Local Authorities.
- The Events strand is an open fund for Local Authorities and other organisations to apply into (please note: **non-Local Authority** organisers can **only** apply with the endorsement of their Local Authority).

Electric Vehicle Charge Point – Tourism Recovery Fund

part of the Destination Net Zero programme, will help support businesses to recover from the impacts of COVID-19 in a sustainable manner and contribute to Scotland's climate target of achieving net zero emissions by 2045.

- This Fund will enable businesses to position sustainability at the heart of their recovery and ensure their offering will make it easier for visitors to make environmentally conscious travel decisions.
- The £325,000 Electric Vehicle Charge Point Fund provides a one-off payment to tourism businesses towards the installation of an electric vehicle charge point. It will support around 100 charge points. The funding available is 75% of the total cost of the charge point and installation (including applicable VAT), up to a maximum of £15,000. The business must pay for the remaining cost.
- Businesses can apply for funding to assist in the installation of an electric vehicle charge point on their premises.
- The Fund is open to all tourism businesses classed as micro or SMEs (small and medium-sized enterprises) that have been trading for at least 12 months.
- Read the full criteria and guidance and apply for funding on the Energy Savings Trust website.
- If you are interested in this please don't delay as the fund is limited and will be allocated on a first come first served basis. Applications are open from 11 May until 8 September (or earlier if budget is utilised before this date).
